Ocean Grove Beaches will be launching a new pilot program this summer called *Sandy Toes*. This will be a children's hour program for four and five year-olds that will meet on Tuesdays from 2:30-3:30pm (with the exception of the last week which will meet on Monday).

Sandy Toes has been developed to provide beach activities for children who are too young for Jr. Lifeguards. Each week there will be a story and activities that relate to a beach theme.

To answer some questions you may have.....

Who will be supervising my child?

Who can participate in *Sandy Toes*?

Any four or five year-old whose family has an Ocean Grove season beach badge is eligible to participate in the program

Where will *Sandy Toes* meet?

We will meet at the beach office to start, and that is where you should pick your child up. However, we will spend some time down on the beach (not in the water).

What should my child bring?

All your child will need to bring is a beach towel to sit on. Please apply sunscreen before dropping your child off, and have them visit the restroom prior to the program starting.

How much does the program cost?

There is absolutely no charge for *Sandy Toes*, however we would like to ask families to consider making a one time \$5.00 donation to OG Beaches' 2010 project Creutzfeldt-Jakob Disease Foundation. (More information about CJD can be found in the 2010 edition of the Pier Post)
